#### **DECISIONS OF SENIOR OFFICIALS COMMITTEE**

December 11, 2020 (Virtual Modality)

The meetings of the Special Working Group (SWG) and Senior Officials Committee (SOC) of the CICA were held virtually on December 09 and 11, 2020. H.E. Mr. Shakhrat Nuryshev, First Deputy Minister of Foreign Affairs of the Republic of Kazakhstan, chaired the SOC meeting. The list of participants is attached as *Annexure I*.

SOC expressed its gratitude and appreciations to the Ministry of Foreign Affairs of the Republic of Kazakhstan for organisation and excellent arrangements for the meetings. SOC also welcomed the newly appointed Executive Director of CICA Secretariat H.E. Ambassador Mr. Kairat Sarybay.

SOC agreed on the following:

- 1. SOC took note of the report of the Executive Director on implementation of CICA CBMs and activities since last meeting of SOC in December 2019.
- SOC tasked the CICA Secretariat to circulate the updated concept paper on introduction of new CBM "Epidemiological safety, public health and pharmaceuticals" to the CICA Catalogue of CBMs and agreed adoption of this CBM through silence procedure by December 25, 2020.
- SOC noted the Concept Paper on Inclusion of the area of "Traditional Medicine" to the CICA CBMs, presented by People's Republic of China, and tasked the CICA Secretariat to compile the inputs of Member States on the initiative and circulate the updated Concept Paper by January 30, 2021.

- SOC approved the CICA Plan of Confidence Building Measures for 2021.
- 5. SOC approved the Budget of CICA Secretariat for 2021.
- 6. SOC noted the requirement of secondment of more diplomats to the Secretariat, in order to internationalize the Secretariat. SOC also encouraged demonstrating the maximum flexibility in approving the secondment of diplomats by the Member States.
- 7. SOC took note of following initiatives proposed by Chairmanship:
  - (i) establishment of the Council of Eminent Persons;
  - (ii) establishment of the CICA Fund.

SOC tasked the CICA Secretariat to compile the inputs of the Member States on the initiatives. These proposals will be discussed at the next SWG and SOC meetings.

- (iii) SOC agreed to hold the CICA Think Tanks Forum on regular basis.
- 8. SOC tasked the CICA Secretariat to provide with proposals related to the term of office of the Executive Director of CICA Secretariat.
- 9. SOC discussed the issue of a more suitable title for Members of Professional Personnel of the CICA Secretariat, and agreed to change the current title with the titles of three categories as 'Associate Officer' – the level of Attaché and Third Secretary, 'Officer' – the level of Second Secretary and 'Senior Officer' – the level of First Secretary and Counsellor. SOC tasked the CICA Secretariat to replace the old title with new ones in relevant CICA documents and circulate among the Member States for approval through silence procedure by January 30, 2021.
- 10. SOC agreed to hold the next meetings of SWG and SOC dedicated to review the status of implementation of CBMs in the first half of 2021. The exact dates and modalities/venue will be communicated through the CICA Secretariat in due course.
