MEMORANDUM

of understanding and cooperation between the Secretariat of the Collective Security Treaty Organisation and Secretariat of the Conference on Interaction and Confidence Building Measures in Asia

The Secretariat of the Collective Security Treaty Organisation (CSTO) and the Secretariat of the Conference on Interaction and Confidence Building Measures in Asia (CICA), hereinafter referred to as the Parties,

based on stated intentions to develop interaction and cooperation within the framework of their objectives and mandates,

noting that international cooperation in countering challenges and threats to the regional and international security helps to create and strengthen an atmosphere of peace, confidence and friendship,

have agreed on the following:

Article 1

Parties shall cooperate and organize interaction within the framework of this Memorandum, proceeding from respective mandates of each Party, exchanging relevant experience and methods in the sphere of countering challenges and threats to the regional and international security, as well as in the sphere of strengthening an atmosphere of peace, confidence and friendship.

Article 2

Parties exchange open-access information including reviews, analytical materials and legal documents of mutual interest.

Article 3

Parties on a mutual basis invite representatives of each other to participate in meetings and conferences organized by Parties.

Parties hold consultations and working meetings including on the sidelines of events organized by international and regional organizations and forums.

Article 4

If necessary, the Parties shall establish joint working groups to prepare proposals for solving the most important issues of mutual interest.

Article 5

Interaction and cooperation of the Parties under this Memorandum shall be implemented in accordance with respective provisions, rules and procedures regulating their activities as well as decisions of their governing bodies.

This Memorandum does not limit the Parties in reaching and implementing similar agreements with other partners.

Article 6

Parties may designate focal points in order to ensure effective interaction and cooperation.

Article 7

This Memorandum may be amended and supplemented by mutual agreement of the Parties, which are formulated by separate protocols, taking effect from the date of its signature.
