EXPLANATORY NOTE to Financial Report for the financial year 2019

In reference of Secretariat's note verbale No.19-5/17emb dated 21 January 2019, regarding the budget of the CICA Secretariat agreed by Member States for the financial year 2019 amounted to - <u>2 049 470</u> (*Two millions forty-nine thousand four hundred and seventy*) US dollars.

The Financial report provides detailed information on revenues and expenditures of the Secretariat in 2019.

The amount of voluntary contributions to the Secretariat's budget in 2019 was - <u>1 114 227</u> (*One million one hundred and fourteen thousand two hundred and twenty-seven*) US dollars including:

from the Republic of Turkey - 25 000 (Twenty five thousand) US dollars;

from the South Korea – 50 000 (Fifty thousand) US dollars;

from the State of Palestine – 12 000 (Twelve thousand) US dollars;

from the Republic of Kazakhstan -1~027~227 (One million twenty seven thousand two hundred and twenty seven) US dollars.

Bank remuneration – 21 997 US dollars, sale of vehicles due to complete wear-out was - 22 561 US dollars and VAT receipts for 2019 is amounted to 19 983 US dollars.

Thus, total amount of revenue is amounted to - 1 178 768 US dollars.

The Secretariat expresses its gratitude to the Member States for their significant contributions and hopes that this year all Member States will contribute to the budget of the Secretariat.

Expenditures including the balance of funds directly in the current accounts and in the cash register of the Secretariat in 2019 amounted to - 651 742 US dollars and were spent in accordance with the approved expenditure items of the Secretariat's budget for 2019.

In 2019 the Secretariat sold light vehicles «Volkswagen PASSAT Lim. COMFO 110 №D080009», «CAMRY2.4 5MT №D080007» and «KIA SPORTAGE №D080008» purchased in 2007 with full accrued depreciation due to not being suitable for further use.

During the year 2019, the Secretariat has strictly followed the principles of optimal use of funds and reasonable cost-effective policies, which allowed to save funds on the expenditures from the approved budget.
