2022 International Online Conference on Mine Safety Risk Prevention and Control among CICA

The member states of Conference on Interaction and Confidence-Building Measures in Asia (CICA) are generally rich in mineral resources. The mining industry is an important foundation for economic and social development. However, due to the constraints of resource preservation conditions and technology readiness level, accidents frequently occur in mines, seriously affecting the safety and health of employees. *The CICA Catalogue of Confidence Building Measures* emphasizes the necessity for industrial safety risk prevention and control. Strengthening communication and cooperation in industrial safety risk prevention and control is in line with the expectations of CICA Member States to improve the safety risk identification level and enhance the enterprise safety risk prevention and control ability. The Ministry of Emergency Management of the People's Republic of China will host the **2022 International Conference on Mine Safety Risk Prevention and Control among CICA**. It aims to improve the level of mine safety risk prevention and protect the safety and health of mine workers among member states by establishing a mine safety risk prevention and control exchange platform. It will further enhance confidence in regional economic development in the post-epidemic era, and promote the sustainable development of the industry. The conference will focus on risk prevention and control for coal mine safety as arranged for this year (Draft Agenda is enclosed herewith Annex I). Representatives from all member states are cordially invited to attend.

encouraged to submit the presentation and cooperation demand on the key topics of the conference by November 15, 2022 Beijing Time.

(i) Institutional mechanisms and policy implementation of coal mine safety risk prevention and control

The conference will discuss different institutional mechanisms and policy implementation that may be used to enhance local coal mine safety risk prevention and control capacity.

(ii) Management experiences of coal mine safety risk prevention and control

The conference will introduce the coal mine safety risk prevention and control management experiences from the views of both government and enterprises.

(iii) Technology support of coal mine safety risk prevention and control

The conference will display advanced technologies such as Management Information System and present technical achievements which support coal mine safety risk prevention and control.

(iv) Best practice cases of coal mine safety risk prevention and control

The conference will share the best practice cases in the field of coal mine safety risk prevention and control and exchange in-depth learning among CICA member states.
