Concept paper of the online experts meeting on the CICA Council on Sustainable Connectivity

30 May 2024, 15:00 Astana Time (UTC/GMT +5 hours)

Introduction

Disruptions in global supply chains force to take a fresh look at the formation of efficient transit-transport corridors. Convenient and accessible transportation routes are an essential factor in the sustainable growth of our CICA member states economies. Focusing on realizing the transit-transport potential by developing diversified communication and cargo delivery routes is important. Therefore, the Kazah Chairmanship has proposed establishing the CICA Council on Sustainable Connectivity.

The first CICA experts meeting occurred on February 29, 2029. During this session, representatives from CICA member states deliberated on a draft Concept Paper, offering their perspectives on establishing the CICA Council of Sustainable Development. Additionally, they shared their expectations and identified priority areas for CICA connectivity initiatives.

Purpose: To discuss the concept paper of the CICA Council on Sustainable Connectivity, along with the relevance and prospects of this body.

Tasks:

- Engaging in collaborative discussions with experts from the CICA Member States to assess the demand for establishing the CICA Council on Sustainable Connectivity, with the aim of reaching a consensus among the CICA Member States;
- Participating in discussions on the CICA Council on Sustainable Connectivity concept paper.

Speaking order:

- Opening remarks by CICA Deputy Secretary General Ms Zhang Ling.
- Welcome remarks by the Department of Transport Policy Director, Ministry of Transport, Republic of Kazakhstan.
- Remarks by representatives of the CICA Member States on establishing the Council on Sustainable Connectivity.
- Closing remarks by the Department of Transport Policy Director, Ministry of Transport, Republic of Kazakhstan.

Working languages: English, Russian (simultaneous interpretation).

Organizers: Ministry of Transport of the Republic of Kazakhstan and CICA Secretariat.

Participants: Representatives of ministries and business entities whose expertise in the transport (railway, air, auto) of the CICA countries.

Concept Paper of the CICA Council on Sustainable Connectivity

This Concept Paper aims to establish the Council on Sustainable Connectivity initiated by the Kazakh Chairmanship at the Sixth CICA Summit in Astana in October 2022.

The Concept Paper is intended to define areas of cooperation of the CICA Member States in sustainable connectivity and, as a consequence, the mandate of the Council on Sustainable Connectivity. This Concept Paper has the following elements: (I) Goals, (II) Principles and (III) Approaches.

I. Goals

- [1. Ensuring peaceful and sustainable development of the CICA Member States.] (RUS TCB)
2. Progressively implementing the UN Sustainable Development Goals.
3. Developing interconnected and efficient infrastructure and systems conducive to the promotion of economic, social and environmental sustainability, which in the long run may include the integration of different types of transport, energy, trade and communication networks.
- [4. Improving the quality of life of the peoples of the CICA Member States.] (RUS TCB)
5. Promoting sustainable development of trade, investment and tourism. Creating conditions to facilitate access to markets, resources, technologies, improve transport and logistics efficiency.
- (6. Developing [maritime] (-KYRG) (-RUS) (+CHAIR) transport[, new logistics] (+CHAIR) routes and trade.) (CHAIR TCB)
- [7. Promoting social development: sustainable connectivity can also facilitate social development in Asia, through the creation of additional jobs, which will lead to greater social inclusion and poverty reduction[, giving marginalized population groups access to economic opportunities] (-RUS).] (RUS TCB)
8. Environment protection: Asia faces a number of environmental challenges, including climate change, deforestation and pollution. Developing sustainable connectivity aims to mitigate this challenge by fostering clean and [[green] (-IND) [sustainable] (+IND) infrastructure and] (+CHN) transport systems, including the implementation of a system to encourage the adoption of sustainable transport modes reducing carbon emissions, enhancing the use of

renewable energy, and promoting sustainable land use and resource management.

[10. Enabling further regional integration: sustainable connectivity can facilitate regional integration and cooperation in Asia. This can help build trust and mutual understanding among countries, improve interaction and information exchange, and advance cultural exchange and tourism.] (IND TCB)

11. Establishing the CICA Council on Sustainable Connectivity[, including] (-RUS) as a platform for sharing best practices, [promoting convergence and mutual recognition of [green] (-PAK) transport-related standards] (+CHN) (-IND) (-RUS) and a dialogue platform for in-depth discussions on transport [and [energy] (-PAK) corridors] (-RUS), logistics infrastructure development, [cooperation on technical standards] (+CHN) (-IND) and environmental sustainability.

II. Principles

All decisions on cooperation development in sustainable connectivity, establishment of the Council on Sustainable Connectivity and interaction of the CICA Member States within this Council are to be made through consultations and based on consensus in accordance with the Almaty Act [and respect for sovereignty and territorial integrity] (+IND) (-PAK); Declaration on the Principles Guiding Relations between the CICA Member States; CICA Catalogue of Confidence Building Measures and Cooperative Approach for the Implementation of the CICA Confidence Building Measures. The Member States may participate in specific events under the Plan of Implementation of Confidence Building Measures on a voluntary basis.

III. Approaches

Progress towards achieving these goals will be gradual and incremental in accordance with national laws and regulations, taking into account specific features and characteristics of different regions of Asia.

The Council on Sustainable Connectivity will be established as a permanent consultative body, meeting at least once a year.

[Each CICA Member State will be represented on the Council on Sustainable Connectivity by one permanent member and one sectoral expert engaged on an ad-hoc basis depending on the agenda item of the Council.] (RUS TCB)
