1. Adoption of the agenda

The initial draft agenda has been circulated as document SWG/2023-II/Agenda/1 on 26 May 2023 and is hereby revised by adding agenda item 5.

2. Draft Road Map for CICA Transformation

The SWG is expected to consider the revised draft Road Map for CICA Transformation (RMT) as contained in document MC/2023/CHAIR/1 on 11 May 2023, finalize it before the next meeting of the Senior Officials Committee (SOC) on 22 August 2023 and recommend its endorsement by the Ministerial Council (MC). The Chairmanship invites Member States to provide their feedback on the draft RMT in advance of the SWG meeting.

3. Draft Decision of the CICA Ministerial Council on a Road Map for CICA Transformation

The SWG is expected to consider the draft MC decision on endorsement of the RMT as contained in document MC/2023/DRAFT/3 on 11 May 2023, finalize it before the next SOC meeting on 22 August 2023 and recommend its adoption by the MC. The Chairmanship invites Member States to provide their feedback on this draft MC decision in advance of the SWG meeting.

4. Draft Decision of the CICA Ministerial Council on Modalities of Implementation of CICA Confidence Building Measures (CBMs)

The SWG is expected to consider the draft MC decision on modalities of CBM implementation as contained in the Attachment of document MC/2023/SEC/1 of 12 May 2023. The Chairmanship invites Member States to provide their feedback on this draft MC decision in advance of the SWG meeting.

5. Draft Statement of the CICA Ministerial Council on Promoting Volunteerism for Sustainable Development

The document was proposed by the Russian Federation, presented at the SOC meeting on 19 April 2023 and circulated among the Member States on 28 April 2023 for comments until 31 May 2023. A new version of the document reflecting comments from Member States was circulated via Secretariat's Note No. SWG/694 of 7 June 2023 and will be considered at the SWG meeting.
