Counter Narcotics Training Academy (NEA); in order to ensure a new vision and understanding of law enforcement training, NEA is established within TNP Counter Narcotics Department upon the approval of the Ministry dated 3.05.2018. All counter narcotics training programs are organized and implemented by NEA.

The NEA is the unique center in Türkiye authorized to provide training activities at the national or international level for the fight against the trafficking of all kinds of narcotics, stimulants and psychotropic substances and the chemical intermediates used to manufacture them, and/or against all criminal activities that constitute predicate drug crimes.

NEA aims to contribute not only to the training of the staff of TNP Counter Narcotics Department but also to the staff of other national and international law enforcement agencies in the field of fight against drugs.

In addition to the national training programs, NEA also organizes and coordinates training programs for member states of Conference on Interaction and Confidence Building Measures in Asia (CICA), Organization for Security and Cooperation in Europe (OSCE), North Atlantic Treaty Organization (NATO), UN Office on Drugs and Crime (UNODC), Economic Cooperation Organization (ECO), Black Sea Economic Cooperation (BSEC), The International Criminal Police Organization, European Police College (CEPOL). Furthermore, NEA carries out training activities within the framework of bilateral security cooperation agreements with 137 countries. NEA organized 1 training program in 2019 with the participation of 10 law enforcement officers from CICA Member Countries (Thailand, Iran, Palestine, Qatar, Azerbaijan, China, India, Mongolia, Kazakhstan and Sri Lanka).

In NEA; training activities are organized in 22 different branches at the national level and 10 different branches at the international level, both in technical and theoretical, practical and operational areas. You can also reach them via these link.

TRAINING ON RISK ANALYSIS AT AIRPORTS AND SEARCH TECHNIQUES

TRAINING PURPOSE

The training course focuses on "Airport Passenger Risk Analysis and Search Techniques" and covers the topics of risk assessment, selectivity, profiling, and search techniques at airports strengthening thereby the participants' knowledge and expertise in this field. This training particularly focuses on how the passenger's profiling, couriers examination and x-ray scanning techniques are implemented by the law enforcement officers at airport. The training is very practically oriented and included study cases examining criminal behaviour and interview methods in addition to luggage profiling and cargo search techniques.
