1. Date and venue

13-14 June 2023 at 10:00 Astana time (*GMT+6*), Beijing Palace Soluxe Hotel Astana, Soluxe Hall (*45 Syganak Str., Astana*).

2. <u>Meeting format</u>

The meeting will be held in a hybrid format. The meeting link for online participants is provided in Annex 1.

Due to the limited capacity of the conference hall, the recommended delegation format for offline participants is 1+1.

3. Registration of participants

Delegates are required to complete the registration form at the CICA Secretariat website – https://s-cica.org/registration.

Visas for participants from countries that do not have diplomatic missions of the Republic of Kazakhstan will be issued upon arrival at the airports of Astana and Almaty (delegates need to send a note with the completed form (enclosed to Annex 3) and forward copies of their passports in electronic form to a.daut@mfa.gov.kz).
