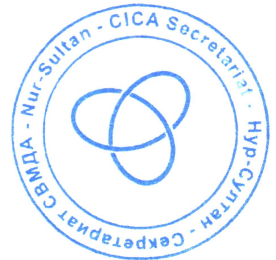

**RECOMMENDATIONS**  
**of the Special Working Group meeting on 12 December 2022**

The Special Working Group (SWG) at its on-line meeting on 12 December 2022 recommended the following:

1. The SWG recommended to the Senior Officials Committee (SOC) that it approve the draft Concept Paper on Cooperation among the CICA Member States in the Area of Tourism.
2. The SWG recommended to the SOC that it approve the draft Concept Paper on Implementation of Confidence Building Measures in the Area of Agriculture as amended at the SWG meeting.
3. The SWG, taking into consideration the views expressed by Member States regarding the need to study preliminary concepts of events and their titles, recommended to the SOC that it consider approving the decision on the CICA Plan of Implementation of Confidence Building Measures and Provisional Calendar of CICA Governing, Working and Advisory Bodies for 2023 with understanding that the concepts of events in the Plan will be finalized in the course of 2023 in accordance with the General guidelines for conducting events on implementation of CICA CBMs.
4. The SWG recommended to the SOC that it approve the decision on the 2023 Budget of the CICA Secretariat.
5. The SWG recommended to the SOC that it decide to carry out an external audit of the financial activities of the CICA Secretariat in 2023 covering the period from September 2020 to 31 December 2022 and to authorize the Independent Audit Company «Asia Astana Audit» to conduct the audit.
6. The SWG recommended to the SOC that it approve the decision on the position of Deputy Secretary General of CICA.
7. The SWG recommended to the SOC that it consider approving the decision on the Staff Matrix of the CICA Secretariat.
