RECOMMENDATIONS of the Special Working Group (SWG) meeting on 6 December 2021

- 1. The SWG recommends to the Senior Officials Committee (SOC) that it adopt the decision on recommendation for CICA Chairmanship in 2022-2024.
- 2. The SWG recommends approval by the SOC of the Concept Paper for 2021-2023 on implementation of confidence building measures (CBMs) in the priority area "Development of small and medium enterprises (SMEs)".
- 3. The SWG recommends approval by the SOC of the Concept Paper on implementation of CBMs in the priority area "Finance".
- 4. The SWG recommends to the SOC to approve
- India as Coordinator in the priority area "Combating terrorism",
- Kazakhstan as Coordinator in the priority area "Epidemiological safety, public health and pharmaceuticals", and
- Russian Federation as Coordinator in the priority area "Security of and in the use of information and communication technologies (ICTs)" for 2022-2023;

and accordingly amend the SOC decision SOC/2021-II/DEC/3 of 8 October 2021 on the list of coordinating and co-coordinating countries for implementing CBMs under priority areas of CICA dimensions.

5. The SWG recommends to the SOC to approve the CICA Plan of Implementation of CBMs for 2022, with recommendation to India and

Uzbekistan to update concepts of the events referred to in items 8, 26 and 27 of the Plan and recommendation to those Member States which did not yet submit preliminary concepts of 2022 events to do so.

- 6. The SWG recommends to the SOC to approve the 2022 Budget of the CICA Secretariat.
- 7. The SWG recommends to the SOC to approve the Staff Matrix of the CICA Secretariat.
- 8. The SWG noted the Chairmanship's intention to continue consultations on membership in the CICA Council of Eminent Persons and the Chairmanship's call to all Member States to nominate candidates to the Council of Eminent Persons, including its Advisory Group, until 31 December 2021, with a view to ensuring as broad geographical representation as possible.
- 9. The SWG will continue consultations on the draft decision on the Regulations for Anniversary Medal "30 years of the Conference on Interaction and Confidence Building Measures in Asia", with a view to finalizing it until the SOC meeting on 8 December 2021. Concerned Member States are expected to send their comments on the draft to the Secretariat in the course of 7 December 2021.
