Concept paper of the round table on New Reality in Information and Communication Technology: Trends and Prospects

In recent years, with the so-called "digital revolution", development of the IT industry and the Internet has been of paramount importance, and has also significantly changed not only the world landscape, but also the structure of relations in it.

The digital format of modern life is changing natural laws, and the virtual space, which has become a real factor in social relations, is reformatting traditional ideas about the methods and mechanisms for storing, circulating and protecting information and intellectual property rights.

IT technology influences the daily life of any person in many ways. They are used to create electronic markets, transferring all payments made to the information space, where payments can be tracked and controlled. Moreover, the development of information technology facilitates creation of additional jobs and retraining of existing personnel, which is directly related to the reduction of unemployment. Information technology has expanded opportunities in the medical, educational, law enforcement fields, which has improved the activities of each institution.

In the context of the new digital reality, the CICA Member States are faced with the task of deepening cooperation and interaction in order to ensure sustainable development of states, as well as to develop policies and strategies in the field of information and communication technology in a changing world order.

Purpose: discussion, exchange of experience and best practices in the development of information and communication technology.

- Impact of modern challenges and threats on the development of information and communication technology.
