#### 1. Adoption of the agenda

The initial draft agenda has been circulated as document SOC/2023-I/Agenda/1 on 16 March 2023 and was revised by adding new agenda items 2 and 6 and sub-item (a) under agenda item 10.

#### 2. Granting the CICA Observer status to the Kingdom of Morocco

The Kingdom of Morocco has submitted a request for obtaining the CICA Observer status. Pursuant to paragraph 12.2 of the CICA Rules of Procedure it has been circulated to all Member States via Secretariat Note No. SOC/413 of 14 April 2023, for consideration by the SOC.

# 3. Regular review of implementation of CICA confidence building measures (CBMs) with focus on the new challenges and threats dimension

Modalities for the review are contained in document SOC/2023-I/CHAIR/1 of 20 March 2023. The Chairmanship calls on all coordinators and co-coordinators in the "New challenges and threats" dimension as well as all other Member States to provide reports and share views on their experience in CBM implementation in this dimension, including possible recommendations, in advance of and at the SOC review meeting.

# 4. Concept papers, coordinators and co-coordinators in priority areas of CICA dimensions

#### 5. Introduction and discussion of the draft Road Map for CICA Transformation

In implementation of paragraph 6 of the Astana Statement on CICA Transformation the Chairmanship has circulated the draft Road Map for CICA Transformation (RMT) for consultation with Member States (document SOC/2023-I/CHAIR/2 of 7 April 2023). The Chairmanship calls on all Member States to provide their feedback on the draft RMT at the SOC meeting.

#### 6. Draft SOC decision on an annual action plan of the CICA Think Tank Forum

The draft annual action plan of the CICA Think Tank Forum (TTF) for 2023 has been agreed by the Member States (Secretariat Note TTF/232 of 1 March 2023) and submitted for approval by the SOC in accordance with paragraph 4.6 of the Regulations of the CICA TTF (document SOC/2023-I/DRAFT/1 of 7 April 2023).

#### 7. Presentation by the Secretary General of the annual financial report for 2022

The SOC is expected to take note of the Financial Report of the CICA Secretariat for 2022 (Secretariat Note BDG/269 of 14 March 2023).

# 8. Auditor's report on the external audit of the financial activities of the CICA Secretariat for the period 1 October 2020 - 31 December 2022

The SOC is expected to take note of the report of the external auditor on the financial and economic activities of the CICA Secretariat for the period from 1 October 2020 to 31 December 2022 (Secretariat Note BDG/270 of 14 March 2023).

#### 9. Activities to raise CICA visibility: CICA Alley

The Chairmanship will inform the SOC on the activities proposed under its initiative on the CICA Alley. The concept of the proposal is contained in document SOC/2023-I/CHAIR/3 of 12 April 2023.
