DRAFT DECISION OF THE SENIOR OFFICIALS COMMITTEE

**Regulations for Anniversary Medal
“30 years of the Conference on Interaction and Confidence Building
Measures in Asia”**

Article 1

General provisions on the Anniversary Medal

- 1.1. The Conference on Interaction and Confidence Building Measures in Asia (hereinafter - CICA) establishes an official award – Anniversary Medal “30 years of the Conference on Interaction and Confidence Building Measures in Asia” (hereinafter - Anniversary Medal).
- 1.2. The medal will be awarded for outstanding services and valuable contribution to strengthening and developing the CICA process and solely given on the occasion of the 30th Anniversary of CICA.
- 1.3. These Regulations define the main characteristics of the Anniversary Medal, nomination and presentation procedures, as well as the categories of persons eligible for the award.
- 1.4. The Anniversary Medal shall have two classes:
 - Medal “30 years of the Conference on Interaction and Confidence Building Measures in Asia”, First Class;
 - Medal “30 years of the Conference on Interaction and Confidence Building Measures in Asia”, Second Class.
- 1.5. The registration of persons awarded with the Anniversary Medal shall be carried out by the CICA Secretariat.

Article 2

Nomination procedure and eligibility

2.1. The nomination for the Anniversary Medal may be initiated by any Member State or the Executive Director of the CICA Secretariat (hereinafter - Executive Director) by submitting a request to the Chairmanship through the CICA Secretariat. Nominations of candidates shall be submitted to the Senior Officials Committee for approval through silence procedure, apart from nominations of high-level candidates of category 2.2.1(a), who will be awarded by the Chairmanship after consultation with Member States.

2.2. The following persons may be nominated for the award:

2.2.1. First Class medal:

a) high-level representatives of Member States nominated according to relevant rules and customs applicable in each Member State;

b) persons who hold or previously held the post of Executive Director.

2.2.2. Second Class medal:

a) government officials of Member States;

b) officials of the CICA Secretariat;

c) officials of international organizations.

Article 3

Medal presentation procedure

3.1. The First Class medal shall be presented by a high-level representative of the Chairmanship or, at the request of the Chairmanship, by the Executive Director.

3.2. The Second Class medal to government officials and public figures of Member States shall be presented by the Executive Director or authorized representative of the foreign ministry of the concerned Member State on

behalf of the Executive Director.

3.3. The Second Class medal to the officials of the CICA Secretariat and officials of international organizations shall be presented by the Executive Director.

3.4. The Anniversary Medal shall be presented during the 30th anniversary year of CICA.

3.5. The Anniversary Medal shall be presented in a solemn atmosphere.

Article 4

Description of the Anniversary Medal

4.1. The Anniversary Medal shall represent a badge circular in form, bearing, on the obverse, an image of the CICA emblem and, on the reverse, the name of the medal in the two working languages of CICA in relief.

4.2. The First class medal shall be made of silver.

4.3. The Second class medal shall be made of yellow metal – brass.

4.4. The Anniversary Medal shall have the weight of 3-300 grams and be 30-40 mm in diameter.

4.5. The person who is awarded the Anniversary Medal shall be issued a certificate signed by the Executive Director.

Article 5

Final provisions

5.1. These Regulations shall be approved by the Senior Officials Committee.
