RECOMMENDATIONS of the Special Working Group meeting on 8 June 2022

The Special Working Group (SWG) at its online meeting on 8 June 2022 recommended the following:

- 1. The SWG discussed the draft Regulations of the CICA Fund and agreed to continue its consideration. Further proposals, if any, are expected until 15 June 2022.
- 2. The SWG took note of the report of the Chairmanship on the status of discussion of the draft Plan of Action on the Implementation of the United Nations Global Counter-Terrorism Strategy (UNGCTS) at the specialized meetings on this subject, the next one scheduled for 21 June 2022.
- 3. The SWG considered the draft Concept Paper on cooperation among the CICA Member States in the area of tourism. Further proposals on the draft Concept Paper are expected until 17 June 2022 for subsequent finalization of the draft either through silence procedure or at the upcoming meetings of SWG and SOC.
- 4. The SWG considered the draft Concept Paper and plan of implementation of the CICA confidence building measures in the priority area "Security of and in the use of information and communication technologies" for 2022-2023. Further proposals on the draft Concept Paper are expected until 15 June 2022 for subsequent finalization of the draft either through silence procedure or at the upcoming meetings of SWG and Senior Officials Committee (SOC).
- 5. The SWG recommends to the SOC to approve Türkiye as Co-coordinator in the priority area "Trade and Investment" and accordingly amend the SOC decision SOC/2021-III/DEC/1 of 8 December 2021 on the list of coordinating and co-coordinating countries for implementing CBMs under priority areas of CICA dimensions.
