
BACKGROUND

As a result of such understanding, the Turkish International Academy Against Drugs and Organized Crime (TADOC) was established within the scope of the Turkish National Police, Anti-Smuggling and Organized Crime Department, and cooperation with the United Nations Office on Drugs and Crime (UNODC) in Ankara on 26 June 2000.







In order to obtain new cooperation channels, TADOC attaches big importance to organizing law enforcement training programs for member states to cooperate with CICA. As a starting point for this promising cooperation between the two institutions, TADOC organized 2 online and 2 face to face training programs in 2021 with the participation of 70 law enforcement officers from CICA Member Countries. (Azerbaijan, Bahrain, Bangladesh, China, Palestine, Qatar, Kazakhstan, Kyrgyzstan, Uzbekistan, Pakistan, Russian Federation, Tajikistan, Thailand, and Jordan)

To enhance current cooperation between CICA and TADOC even further, TADOC will continue its support to CICA by providing a "Law Enforcement Training Program on Anti-Money Laundering and Counter Financing of Terrorism" for the use of CICA member countries.

AIM OF THE PROGRAM

This program aims to equip law enforcement officers in anti-money laundering and counter-financing of terrorism units in countries with the necessary knowledge, skills, and abilities that will help them successfully fulfill their tasks and responsibilities.
