Cluster 3. International status of the Secretariat – amending Host Country Agreement

Draft amendments to the Host Country Agreement were agreed by Member States on 19 July 2024.

Next steps:

- ❑ Decree of the Government of Kazakhstan
- ❑ Signing by the Government of Kazakhstan and the Secretary General
- ❑ Ratification by the Parliament of Kazakhstan.

Priorities and initiatives for 2020-2022 and 2022-2024



CONFIDENCE BUILDING MEASURES (CBMs): Strengthening the Implementation

- **January 2021, SOC:** new CBM on Epidemiological safety
- **June 2021 , SOC:** **General Guidelines for Conducting Events on CBM Implementation**
- **October 2021, 6th Ministerial meeting:** updated **CICA Catalogue of CBMs:**
18 priority areas / list of coordinators and co-coordinators
- **June 2022, April 2023, June 2024, SOC:** annual review of CBM Implementation
- **August 2024, SOC:** approved draft **Modalities of CBM implementation**
to be adopted at **7th Ministerial Council meeting** (Baku, 19 December 2024)

Priorities and initiatives for 2020-2022 and 2022-2024



Three new permanent institutions

- **Council of Eminent Persons** (initiated at Fifth CICA Summit in 2019): established in October 2021, 6th Ministerial meeting, membership pending
- **Think Tank Forum** (initiated by China in 2014) transformed into a permanent institution in October 2021, 11 meetings held
- **CICA Fund**: (initiated at Fifth CICA Summit in 2019): established in October 2022, Sixth CICA Summit, open for projects and funds

Sixth CICA Summit (Astana, 12-13 October 2022)

OUTCOMES (other than mentioned above):



- **CICA Plan of Action on Implementation of UN Global Counter-Terrorism Strategy;**
- **Joint CICA Leaders' Statement on Cooperation in the Field of Security of and in the Use of ICTs** (Russian-Chinese Initiative);
- **Decision on the Kazakh Chairmanship in 2022-2024,**
dates of next MC meetings and Summit.
- **Appointment of the first CICA Secretary General** for four years.

Priorities and initiatives for 2022-2024 Sixth CICA Summit (Astana, October 2022)



- ✓ **Ministerial Conference on Environmental Issues** online on 28 August 2024. Adopted a **high-level statement** committing to enhanced cooperation, water management, climate action aligned with the UNFCCC and the Paris Agreement.
- **Rally of Volunteer Movement Leaders** under auspices of **7th CICA Youth Council ministerial meeting** (Astana, 3-4 October 2024) to strengthen youth exchange and cooperation of volunteer organizations. **Ministerial Statement on Promoting Volunteerism for Sustainable Development** adopted at **informal CICA MC meeting** (September 2023, New York).
- **Partnership Network of Leading Universities (PNLU)**: to enhance cooperation in education, science and technology. The SOC has finalized the **PNLU Memorandum. 7th CICA MC meeting (Baku, 19 December 2024) to adopt the Memorandum and inaugurate the PNLU.** Nomination of universities from MSs are expected.

Priorities and initiatives for 2022-2024 Sixth CICA Summit (Astana, October 2022)



- **Institutionalization of the Finance Summit** to develop financial cooperation in the CICA region: **concept paper** and draft **Regulations** of the CICA Finance Summit were circulated on 31 July, expecting feedback from MSs. First expert meeting held on the margins of **Astana Finance Days** on 6 September 2024.
- **Council on Sustainable Connectivity (CSC)**: unleashing the transit potential of MSs and strengthening sustainable transportation corridors. Echoing with **priorities of incoming Chairmanship of Azerbaijan**. Initiative being discussed at CICA expert meetings since February 2024

Ratification by Bangladesh in 2023, by China and Jordan in 2024

10 Member States signed and ratified



4 ratifications required for entry into force

8 Member States which signed but not ratified



CICA expansion and external relations since 2020

- 2021:** **Turkmenistan** – 9th Observer
SOC approval of establishing partnership with the Eurasian Economic Union (EAEU)
SOC approval of establishing partnership with ASEAN
- 2022:** **Kuwait** – 28th Member State
Eurasian Economic Union (EAEU) – 6th Partner Organization
Dialogue with *ASEAN*
- 2023:** **Saudi Arabia** – 10th Observer
Application of *Morocco* for Observer status (pending)
- 2024:** SOC approved establishing partnership with ***UN Office of Counter-Terrorism (UNOCT)***:
MoU under consideration.
SOC approved MoU with ***UN ESCAP*** on 12 September 2024. Signing the MoU will make ESCAP the
7th Partner Organization.
